- damages related to licensure issues and client's termination of the lease. We prevailed on our motion for summary judgment, obtaining dismissal of all of the plaintiff's claims.
- Representing a medical staffing company in a breach of contract and fraud action and related shareholder oppression dispute with several minority shareholders. Obtained a temporary injunction precluding company's minority shareholders and former employee from competing against our client and otherwise using the client's confidential and proprietary information.
- Represented a publicly traded healthcare company in a fraud and breach of fiduciary duty
  case against a financial advisory firm. Successfully settled the case, with our clients
  receiving several million shares of stock that defendants held in our client's company.

  to a defective computerized fleet management system implemented by the client. After a
  fast track arbitration in which all depositions, expert reports, pre-hearing briefings, and the
  evidentiary hearing took place in 30 days, we obtained a favorable award for our client on
  all claims.
